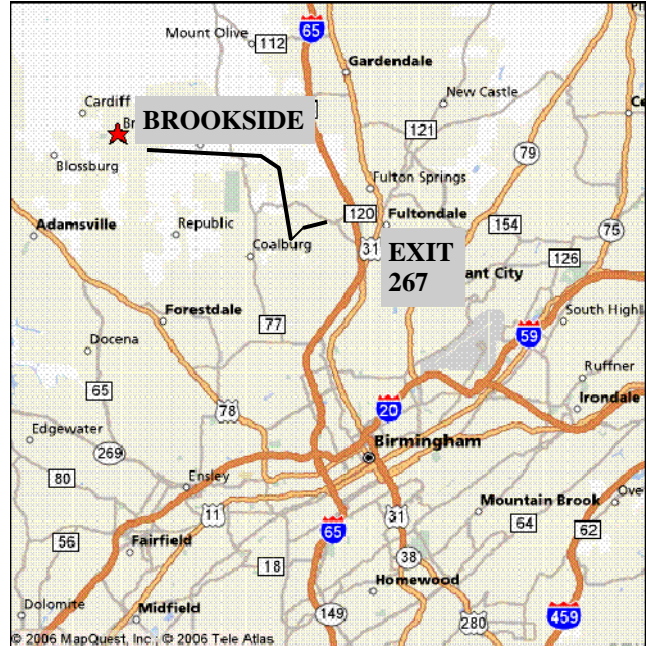

0.4 miles *'T' intersection*
Right on Coalburg Road/ CR 77
4.7 miles
Right onto Bivens-Brookside Rd
0.9 miles (At Sharon Heights Church)
Cross Five Mile Creek bridge
in old Brookside.
Straight at stop sign.
First left, first right, over bridge.
